ARTICLE I - NAME

The name of this corporation is One Stop Marketing, Inc.

ARTICLE II - DURATION

The corporation shall have perpetual existence, commencing on the date of executing and acknowledgment of these Articles.

ARTICLE III - PURPOSE

The corporation is organized for the following purposes:

ARTICLE IV - POWERS

The corporation shall have all the corporate powers enumerated in the Florida Business Corporation Act.

Meetings of shareholders and directors, including the time, place and manner of calling such meetings, shall be fixed by the by-laws of the corporation.

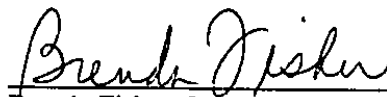
#### ARTICLE X - AMENDMENT

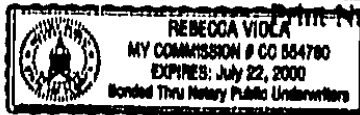
