ARTICLES OF INCORPORATION

OF

ONE STOP MARKETING, INC.

The name of this corporation is One Stop Marketing, Inc.

ARTICLE II - DURATION

The corporation shall have perpetual existence, commencing on the date of executing and acknowledgment of these Articles,

ARTICLE III - PURPOSE
