ARTICLE ONE

THE NAME OF THE CORPORATION IS OLIVER'S BUSINESS SERVICES INC.

ARTICLE TWO

THIS CORPORATION IS TO PROVIDE A VENTURE, WHEREAS, WE WILL BUY AND SELL AND REFURBISH HOMES.
