ARTICLES OF INCORPORATION

ARTICLE I

NAME

The name of the Corporation is INTERNATIONAL FUNDING RESOURCES, INC. The address of the Corporation is 14706 Par Club Circle, Tampa, Florida 33624.

ARTICLE II

DURATION

The Corporation shall have perpetual existence.

PURPOSE
