ARTICLES OF INCORPORATION

OF

JC FITNESS INTERNATIONAL, INC.

THE UNDERSIGNED, acting as incorporator of a corporation under the riorida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME

The name of this corporation is: JC FITNESS INTERNATIONAL INC.

ARTICLE II DURATION

The duration of this corporation is perpetual.

ARTICLE III PURPOSK

The purposes for which this Corporation is organized are to engage in any activities or business permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.

ARTICLE IV CAPITAL STOCK

This Corporation is authorized to issue 10,000 shares of common voting stock at \$1.00 par value per share. Fully-paid stock of this Corporation shall not be liable to any further call or assessment. This article pertaining to preemptive rights may not be amended or deleted without the unanimous vote of the Shareholders of each affected class, and no issuance of stock of the Corporation shall take place unless the price at which the stock is to be issued shall be approved by a majority of the shareholders of the Corporation.
