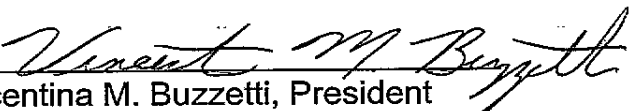
SECOND: The date of the adoption of these Articles of Dissolution is 19 April 1999.
