

### ARTICLES OF INCORPORATION

OF

NOCATEE COIN LAUNDRY, INC.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

#### **ARTICLE ONE**

NAME

The name of the corporation is NOCATEE COIN LAUNDRY, INC.

#### **ARTICLE TWO**

#### **DURATION**

The term of existence of the corporation shall be perpetual.

This right may also be walved by affirmative written walver submitted by the shareholder to the corporation with thirty (30) days of receipt of notice from the corporation.
