# ARTICLES OF INCORPORATION

# ARTICLE I. CORPORATE NAME.

The name of this corporation is A.R.T. HOLDINGS, INC. and the principal place of business and mailing address of this corporation is 114 Hammock Pine Boulevard, Clearwater, Florida 34621.
