ARTICLES OF INCORPORATION
OF

The undersigned incorporator to these articles of incorporation, being duly licensed to practice law under the laws of the state of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the state of Florida.

ARTICLE I

The name of this professional service corporation is Ricardo A. Gonzalez, P.A.

ARTICLE II

ARTICLE III

ARTICLE IX


This corporation reserves the right to amend or repeal any provisions in these articles of incorporation in the manner provided by law. Any right conferred on the shareholders is subject to this reservation.

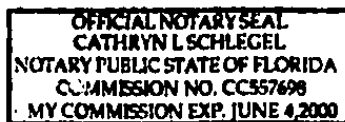




**CERTIFICATE OF DESIGNATION OF
