

ARTICLES OF INCORPORATION

ARTICLE I

NAME

The name of this corporation shall be:

SUN SIGNS GRAPHIC DESIGNS, INC.

ARTICLE II

Existence of Corporation

This corporation shall begin existence on August 30, 1996 and have perpetual existence.

ARTICLE III

Purposes

This corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the law of the State of Florida.

ARTICLE IV

General Powers

The corporation shall have the power:

ά

- (a) To have a corporate seal, which may be altered at will, and to use it or a facsimile of it, or by impressing or affixing it or in any other manner reproducing it;
- (b) To purchase, receive, or lease, or otherwise acquire, own, hold, improve, use and otherwise deal with real or personal property or any legal or equitable interest in property wherever located;
- (c) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange or otherwise dispose of all or any part of its property;
- (d) To lend money to, and use its credit to, assist its officers and employees in accordance with the Florida Statutes;
- (e) To purchase, receive, subscribe for, or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, pledge, or otherwise dispose of, and deal in and with shares or other interests in, or obligations of, any other entity;
- (f) To make contracts, guarantees, incur liabilities, borrow money, issue its notes, bonds, and other obligations, (which may be convertible into or include the option to purchase other securities ed, the corporation), and secure any of its obligations by mortgage or private of any of its property, franchises, and income and make contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by the contracting corporation; a corporation which owns, directly or indirectly, a majority of the

outstanding stock of the contracting corporation; or a corporation the majority of the outstanding stock of which is ewood, directly or indirectly, the majority of the outstanding stock of the contracting corporation, which contracts of guaranty and surstyship shall be deemed to be necessary or convenient to the conduct, promotion, or attainment of the business of the contracting corporation, and make other contracts of guaranty and surstyship which are necessary or convenient to the conduct, promotion, or attainment of the business of the conduct, promotion, or attainment of the business of the contacting corporation;

- (g) To lend money, invest and reinvest its funds, and receive and hold real and personal property as security for repayment;
- (h) To conduct its business, locate offices, and exercise the powers granted by this act within or without the state;
- (1) To elect directors and appoint officers, employees and agents of the corporation and define their duties, fix their compensation, and lend them money and credit.
- (j) To make and amend bylaws, not inconsistent with its Articles of Incorporation or with the laws of this state, for managing the business and regulating the affairs of the corporation;
- (k) To make donations for the public welfare or for charitable, scientific, or educational purposes;
- (1) To transact any lawful business that will aid governmental policy;
- (m) To make payments or donations or do any other act not inconsistent with law that furthers the business and affairs of the

corporation;

- (n) To pay pensions and astablish pension plans, pension trusts, profit-sharing plans, share benus plans, share option plans, and benefit or incentive plans for any or all of its current or former directors, officers, employees, and agents and for any or all of the current or former directors, officers, employees, and agents of its subsidiaries;
- (0) To provide insurance for its benefit on the life of any of its directors, officers, or employees, or on the life of any shareholder for the purpose of acquiring at his death shareholder stock owned by the shareholder or by the spouse or children of the shareholder; and
- (p) To be a promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other entity.

ARTICLE V

Capital Stock

(a) The total number of shares of Capital Stock authorized to be issued by the corporation shall be 100 shares. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting to the stockholders. All or any part of said capital stock may be paid for in cash, in property or in labor or services actually performed for the corporation and valued at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for

and phall be nonappeopable.

(b) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.

ARTICLE VI

Proemptive Rights and Shareholders Rights of First Refusal

The Stockholders of the Corporation shall have the preemptive rights to subscribe for and purchase their proportionate share of any additional stock issued by the corporation, from and after the issuance of the shares originally subscribed for by the stockholder of this corporation, whether such additional shares be issued for cash, property, services or any other consideration, and whether or not such shares be presently authorized or be authorized by subsequent amendment to these Articles of Incorporation.

Shareholders shall have the right of first refusal if any other shareholder wishes to sell. The price of the shares shall be the fair market value as agreed among the parties. If there is no agreement, then a business appraiser shall be retained to value the stock.

ARTICLE VII

Registered Office and Registered Agent

The street address of the corporation's initial registered office is 811 Harrison Avenue, Panama City, Florida, 32401, and the name of the corporation's initial registered agent at such address

is Terry Lee Gagnen. The mailing address of the corporation's principal office is 811 Harrison Avenue, Panama City, Florida, 32401. The corporation may change its registered office or its registered agent or both by filling with the Department of State of the State of Florida a statement complying with Section 607.0502, Florida Statutes.

ARTICLE VIII

Directors

This corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time by the Bylaws, but shall never be less than one (1). The names and addresses of the initial directors of the corporation are:
