### ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of FLORIDA.

#### ARTICLE I - DURATION

This corporation shall exist perpetually unless dissolved according to FLORIDA Law.

#### ARTICLE II - PURPOSE
