We the undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I - Name

The name of the corporation shall be:

G. A. W. S. C. MANAGEMENT CORPORATION

ARTICLE II - Principal Office

ARTICLE III - Perpetual Duration

The Duration of the corporation is perpetual.

ARTICLE IV - Purposes

The general purposes for which the corporation is organized are:

1. To buy and sell real property to lease and exchange the same.
