ARTICLE I. NAME

The name of the corporation is:

T O E R, Inc

Its business shall be conducted in the United States and its possessions and in all foreign countries, wherever necessary or convenient.

ARTICLE II. BUSINESS

The general nature of the business or businesses to be transacted, conducted and carried on by this corporation shall be to engage in any activity or business permitted under the laws of Florida.

ARTICLE III. CAPITAL STOCK

The corporation shall have the authority to issue 100,000 shares of common stock, each share to have no par value. These shares may be issued for the consideration expressed in dollars as may be fixed by the Board of Directors.

ARTICLE IV. PRE-EMPTIVE RIGHTS

Every holder of the common stock of the corporation upon the sale or issuance of any new stock of the same kind, class or series as that which he already holds or any securities or obligations convertible into said stock, shall within thirty days (30) from the authorization or approval for sale of said stock, securities or obligations, have the right to purchase or subscribe to his pro-rata share thereof at the price at which it is offered to others. In the event that then existing stockholders notify the Board of Directors that they do not wish to exercise this pre-emptive right or fail to take any action in regards to this matter within the thirty (30) days period, said stock, securities or obligations may be disposed of for such considerations and to such persons the Board of Directors may determine.

ARTICLE V. TERM

The term for which this corporation is formed is and shall be perpetual or until dissolved according to law.

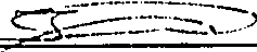

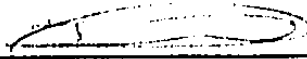
