The name of the Corporation is HI-TECH RECOVERY & RECYCLING OF DADE COUNTY, INC.

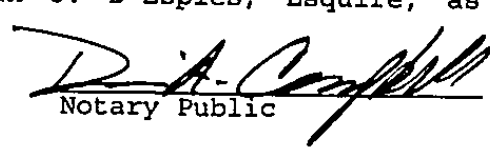

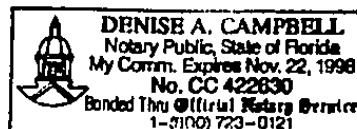
