ARTICLES OF INCORPORATION NATIONSWAY MORTGAGE FUNDING CORPORATION

THE UNDERSIGNED subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

I

The name of this corporation shall be NATIONSWAY MORTGAGE FUNDING CORPORATION and the principal place of business shall be 5511 N.W. 88TH TERRACE, CORAL SPRINGS, FLORIDA 33067.

II
