ARTICLE I NAME

The name of this corporation is: FRANKLIN FEED & GRAIN, INC.

ARTICLE II GENERAL PURPOSE

The general purpose or purposes for which the corporation is organized is the transaction of any or all lawful businesss for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE III CAPITAL STOCK


