ARTICLE VII - Incorporator

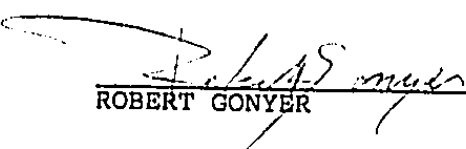

ARTICLE IX - Indemnification

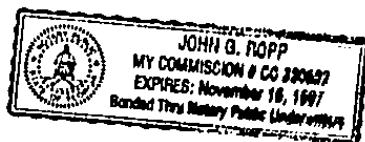

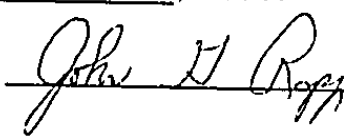

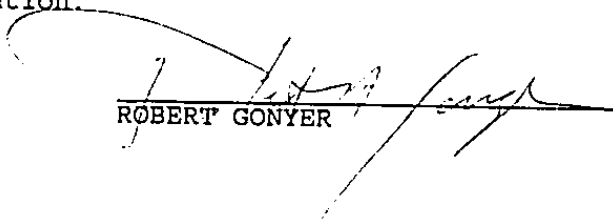
