The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation shall be:

The principal place of business of this corporation shall be:

ARTICLE II - NATURE OF BUSINESS

This corporation shall engage in or transact any lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares of stock and its outstanding par value that the corporation is authorized to have outstanding at any one time is:
