The name of this corporation is: SOUTHERN PRIDE TRAILER
SALES, INC.

ARTICLE II - PURPOSE

The general nature of the business or businesses to be
transacted in to transact any lawful business and to exercise all
powers granted to corporations by the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares with par value that this
corporation is authorized to have outstanding at any one time is
Seven Thousand Five Hundred (7,500) shares of voting common stock

such provision be noted conspicuously on the face or back of each
and every certificate of shares subject to the terms and conditions
of any such agreement.


