ARTICLES OF INCORPORATION OF

A-PLUS PACKING AND MOVING, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is A-PLUS PACKING AND MOVING, INC.

SECOND: The period of its duration is perpetual.
