**ARTICLES OF INCORPORATION
OF
AYW TRADING, INC.**

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **AYW TRADING, INC.**

ARTICLE II

The existence of the corporation shall begin on **AUGUST 28, 1996**, the date of the subscribing and acknowledgment of these Articles of Incorporation, and shall exist perpetually thereafter until dissolved sooner according to law.

ARTICLE III

The street address of the principal office of the Corporation is **12924 S.W. 112 Court, Miami, FL 33176.**

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is **7,500**, all of which shall be one dollar (\$1.00) par value Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

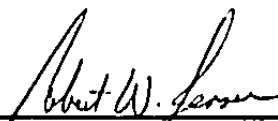
ARTICLE VII

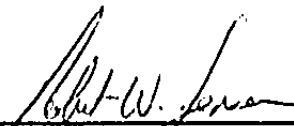
