ARTICLES OF INCORPORATION
OF
IT'S A CHILD'S WORLD, INC.

ARTICLE ONE

The name of the corporation is **IT'S A CHILD'S WORLD, INC.** The principal address of the corporation is: 1430 N.W. 71st Avenue, Plantation, Florida 33313.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**


ARTICLE FIVE

The corporation will not commence business until it has received for the issuance of shares consideration of the value of \$1,000.00 consisting of money, labor done or property actually received.


ARTICLE EIGHT
