1. Luis A. Martinez is the Secretary of GARO APPARELS, INC., a Florida corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on September 26, 1997.
3. That the Corporation failed to file its 1997, 1998, and 1999 Annual Reports or pay the 1997, 1998, and 1999 Annual Reports filing fee within the time prescribed by Florida Statutes Chapter 607 because:
