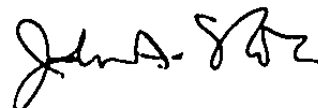

ARTICLE ONE

The name of the corporation is THE BACH GROUP OF SARASOTA, INC. The principal office of the corporation is 677 North Washington Boulevard, Suite 10, Sarasota, Florida 34236.

ARTICLE TWO

The period of its duration is perpetual.

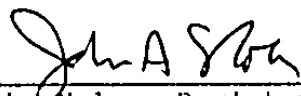
