OF

The **ARTICLES OF INCORPORATION** of **R.C.'S SATELLITE SERVICE, INC.**, are as follows:

ARTICLE I.

The name of this corporation shall be **R.C.'S SATELLITE SERVICE, INC.**

ARTICLE II.

The duration of this corporation is perpetual.

ARTICLE III.

This corporation is organized for transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, or under the laws of the State of Florida, except that said corporation shall not conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

ARTICLE IV.

The aggregate of shares of stock of said corporation shall be 100 shares of common stock with a par value of \$1.00.
