ARTICLE I - NAME

The name of this corporation is TOUCH COLOR INDUSTRIES, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of filing these Articles of Incorporation with the Department of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.


ARTICLE X - POWERS

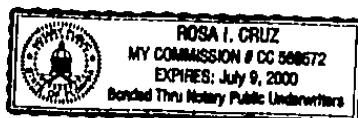




