The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the Corporation is: **D. V. ASSESSMENTS.** The mailing address for the Corporation is: **172 Point O' Woods Drive, Daytona Beach, Florida 32114.**

**ARTICLE II - NATURE OF DURATION**

The term of existence of the Corporation is perpetual.

**ARTICLE III - NATURE OF BUSINESS**

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which the Corporation has authority to issue is One Hundred (100), all of which shall be common shares with a par value of \$1.00 per share.

**ARTICLE V - REGISTERED OFFICE**

The street address of the initial registered office of the Corporation is: **172 Point O' Woods Drive, Daytona Beach, Florida 32114;** and the name of the initial registered agent at such address is: **Craig Allen Golgowski.**

**ARTICLE VI - MANAGEMENT**

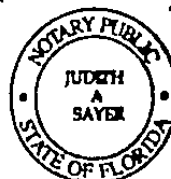
