ARTICLES OF INCORPORATION

Article I - Name

The name of the corporation shall be:

APC CONSULTING, INC.

The principal place of business of this corporation shall be 511 North Broughton Square, Boynton Beach, FL 33436.

Article II - Duration

This corporation shall commence its corporate existence on the date of execution and acknowledgment of these Articles.

Article III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

Article IV - Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock having \$1 par value per share.
