ARTICLE I -- NAME

THE NAME OF THIS CORPORATION UNDER CODE SECTION 621 OF FLORIDA STATUTES IS TERRY SMALL P.A.

ARTICLE II -- PURPOSE

THIS ORGANIZATION IS ORGANIZED FOR THE PURPOSE OF TRANSACTING BUSINESS AS A LICENSE REAL ESTATE PERSON.

ARTICLE III -- DURATION


ARTICLE IX - INDEMNIFICATION

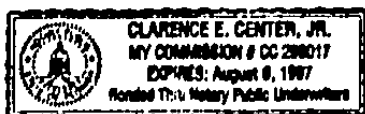




