ARTICLE I  
NAME AND ADDRESS

The name of the corporation is IN ADDITION, INC. (the "Corporation"). The address of the principal office of the Corporation shall be 16308 N.W. 11th Street, Pembroke Pines, Florida 33028. The mailing address of the Corporation shall be the same as the address of the principal office.

ARTICLE II  
DURATION

The Corporation shall have a perpetual existence commencing upon filing of the Articles of Incorporation with the Secretary of State.

ARTICLE III  
PURPOSE

The Corporation shall be authorized to engage in and transact any and all lawful business within and without the State of Florida or United States for which corporations may be incorporated under Chapter 607, Florida Statutes, as amended and supplemented.

ARTICLE IV  
POWERS

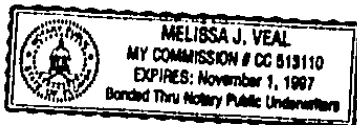
