

The undersigned, FRED C. LIENHARD, competent to contract, for the purposes of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such Corporation:

- FIRST:** The name of the proposed corporation is **VALUVEND, INC.**
- SECOND:** The Corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida
- THIRD:** The total number of shares of stock which the Corporation shall have authority to issue is Ten Thousand (10,000) shares, which shall be Common Stock. Par Value - \$1.00 per share.
- FOURTH:** The amount of capital with which the Corporation will begin business is \$500.00.

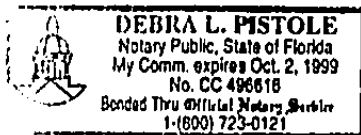
