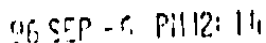

ARTICLE 1

NAME

The name of this Corporation is NEW SEAL PRODUCTIONS, INC.

ARTICLE 2

PRINCIPAL PLACE OF BUSINESS

The principal place of business of this Corporation shall be 1251 Thatch Palm Drive,
Boca Raton, FL 33432.

ARTICLE 3

MAILING ADDRESS

ARTICLE 4

PURPOSES AND POWERS

This Corporation may engage in any activity or business permitted under the
laws of the United States and the State of Florida, including, but not limited to music and
video production and any and all business activities related thereto.

ARTICLE 5

CAPITAL STOCK

The aggregate number of shares which this Corporation shall have authority to issue
is One Thousand (1,000) shares of Common Stock, having a par value of ONE DOLLAR

INDEMNIFICATION


The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


