INDEMNIFICATION



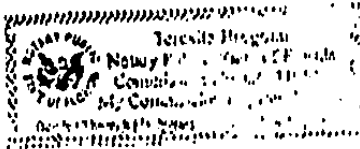
