ARTICLES OF INCORPORATION
OF
SOUTHERN SAUCE AND SPICES, INC.

ARTICLE I. CORPORATE NAME.

The name of this corporation is SOUTHERN SAUCE AND SPICES, INC.

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation is 2935 Harvard Avenue, Jacksonville, Florida 32210.

ARTICLE III. DURATION.

The duration of the Corporation is perpetual.

ARTICLE III. CAPITAL STOCK.

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 300.

ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE.

ARTICLE V. INITIAL BOARD OF DIRECTORS.

By acquiring shares in this Corporation, each Shareholder agrees to abide by this right and to elect each of the initial Directors named in these Articles of Incorporation to the office of Director as long as that Director is a Shareholder of the Corporation. This Article may not be amended in any way without the written consent of each of the initial Directors who is a Shareholder of the Corporation at the time of the amendment.

ARTICLE V. SHARE TRANSFER RESTRICTIONS.

Shares of the Corporation shall be issued to the following persons in the following amounts upon payment of the consideration determined by the Board of Directors:


Shares held by each Shareholder may not be sold or otherwise transferred to other persons (other than transfer to an heir in the case of a shareholder's death) unless first offered to this Corporation or to the remaining Shareholders in proportion to their shares. The price, terms and other provisions regarding this restriction may be specified by written agreement among the

Shareholders, which agreement may expand this Article and which may also include the Corporation as a party. These restrictions are intended to preserve exemptions under federal and state securities laws, to provide for orderly changes in ownership of shares, and to serve other reasonable purposes.


ARTICLE X. AMENDMENT.
