Pursuant to Sections 607.1001, 607.1003 and 607.1006 of the Florida Statutes, **PARKING STRUCTURE GROUP, INC.**, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **PARKING STRUCTURE GROUP, INC.**
2. Article I of the Corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:
