ARTICLE I. NAME

The name of this corporation shall be Victor A. Norell, P.A.




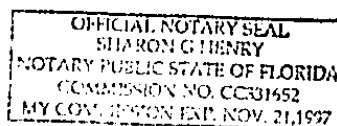
