
All voting power of this corporation shall be vested in the common stock above designated.



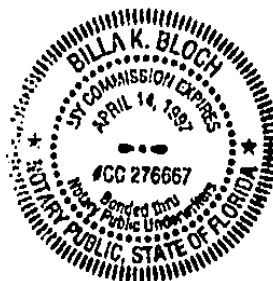
