**ARTICLE I**

**NAME AND PRINCIPAL OFFICE**





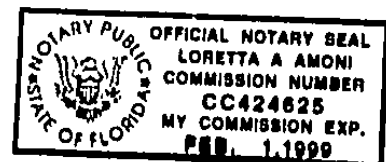
