The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts those Articles of Incorporation.

**ARTICLE I - NAME OF THE CORPORATION**

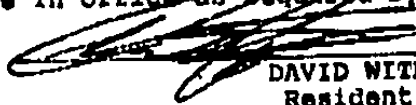
