**ARTICLES OF INCORPORATION
OF
DIMENSIONAL DATA DESIGN, INC.**

The undersigned, for purposes of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be DIMENSIONAL DATA DESIGN, INC.

**ARTICLE II
DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III
PURPOSE**

The purposes of the corporation are:

(a) To engage in the business of designing, manufacturing, producing, marketing and distribution of three-dimensional display products, and related activities.

(b) To engage in and to transact any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

**ARTICLE IV
CAPITAL STOCK**

The aggregate number of shares which the corporation has authority to issue is one thousand (1000) shares, all of which

shall be common shares with a par value of one dollar (\$1.00).

**ARTICLE V
REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the initial registered office of the corporation is 201 E. Pine Street, Suite 1402, Orlando, Florida 32801. The name of the initial registered agent at such address is Ramsey Dulin.

**ARTICLE VI
PRINCIPAL PLACE OF BUSINESS**
