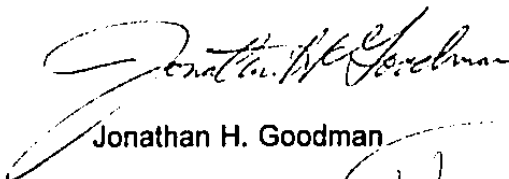

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is SOUTHERN NATIONAL VENTURES, INC.

ARTICLE II.

The main location where the company shall conduct its business is 2313 Plantation Lake Drive, St. Augustine, Florida 32086.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.

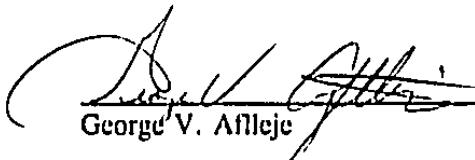

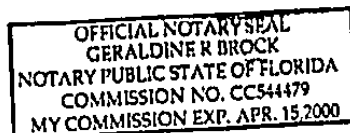

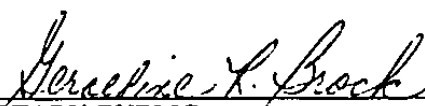
