ARTICLE I


ARTICLE VIII

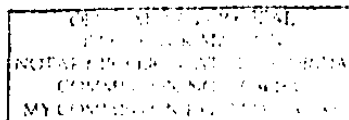
