## ARTICLE 1 - NAME

The name of this corporation is RAIMUNDO A. LOPEZ-LIMA, M.D., P. A.

## ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida. Corporate existence shall commence at the time of filing of the Articles by the Department of State, State of Florida.

- 78. To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this state.
- To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.
