

# ARTICLES OF INCORPORATION

OF

## EASON AVIATION AND MARINE, INC.

The undersigned, acting as Incorporator's to these Articles of Incorporation, of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

# ARTICLE L

#### NAME

The name of the Corporation is EASON AVIATION AND MARINE, INC.

# ARTICLE 11

To own and operate an aviation and marine business and to buy and sell airplanes and frame in the wholesale and retail markets. To also sell and distribute a markets are marine parts and accessories and to maintain a service and repair depression for airplanes and boats.
