

ARTICLE I - NAME

The name of the Corporation shall be:

EVERSEAL ENTERPRISES, INC.

The principal place of business shall be:

ARTICLE II - DURATION

This Corporation shall exist perpetually commencing on the date these Articles are filed.

ARTICLE III - NATURE OF BUSINESS

This Corporation may engage in or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue one thousand (1,000) shares of \$.01 par value common stock which shall be designated "Common Stock".

This Corporation elects to have preemptive rights.


ARTICLE XIII - AMENDMENT


