

ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of this corporation is M&S PAINTING & SIDING, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of signing.

ARTICLE III - PURPOSE
