**ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be Downtown Cigar Company. The principal place of business shall be 2940 Mary's Way, Palm Beach Gardens, Florida 33410.

ARTICLE II. NATURE OF BUSINESS

The Corporation may engage in or transact all lawful activities or businesses permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The total number of shares of capital stock of all classes which the Corporation shall have authority to issue is one million (1,000,000) shares, \$0.01 par value per share. (Hereinafter collectively referred to as "Common Stock".)

The designations, preferences, privileges and powers, and relative, participating, optional or other special rights and qualifications, limitations or restrictions of the Common Stock shall be identical in all respects.

ARTICLE IV. ADDRESS

The street address of the initial registered office of the Corporation shall be c/o Tom Pierce, 2940 Mary's Way, Palm Beach Gardens, Florida 33410; and the name of the initial registered agent of the Corporation at that address is Thomas K. Pierce.

ARTICLE V. TERM OF EXISTENCE

The Corporation shall exist perpetually.

ARTICLE VI. DIRECTORS

The Corporation shall have three (3) directors initially.

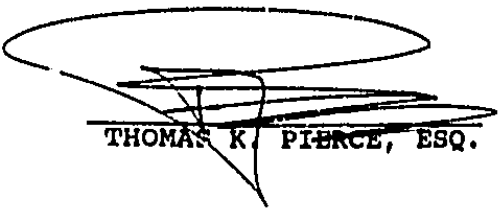
