ARTICLE I - NAME OF COMPANY

The net assets of the Company remaining after winding up have been distributed to the shareholders.

ARTICLE IV - COMPANY OBLIGATIONS

The Company does not have any judgments outstanding or suits pending against the Company in any court.

ARTICLE V - AUTHORIZATION FOR DISSOLUTION
