ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of BUSINESS SOLUTIONS CONSULTANTS, CORP., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is BUSINESS SOLUTIONS CONSULTANTS, CORP.

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE

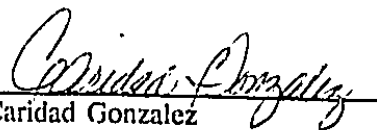
### ARTICLE VIII. BYLAWS

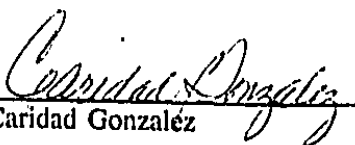
