ARTICLES OF INCORPORATION OF ONE TRUST, INC.

The undersigned, acting as incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE

NAME

The name of the Corporation is ONE TRUST, INC.

ARTICLE II

DURATION

The Corporation shall have perpetual existence.

ARTICLE III
